- 3) Tracking Error: Tracking error is the divergence between the price behavior of a position or a portfolio and the price behavior of a benchmark. Tracking error is reported as a standard deviation percentage difference, which reports the difference between the return an investor receives and that of the benchmark they were attempting to imitate. - 4) **Beta:** Beta is a measure of the volatility—or systematic risk—of a security or portfolio compared to the market. Beta data about an individual stock can only provide an investor with an approximation of how much risk the stock will add to a (presumably) diversified portfolio.

The IR is often used as a measure of a portfolio manager's level of skill and ability to generate excess returns relative to a benchmark.


